- Support in **developing capacities** for the implementation of territorial development

Who can apply?

- 1. For the development of a territorial strategy focused on one city:
- Local self-government, with the status of a city, classified as an urban area - centre of integration with a minimum of 40,000 inhabitants
- 2. For the development of a territorial strategy focused on multiple local self-governments:
- One of the local self-governments with the status of a city, classified as an urban area centre of integration with a minimum of 40,000 inhabitants
- To meet the requirement of spatial continuity of the territory;
- To ensure partnership with at least three (3) local self-governments
- To ensure partnership with a Regional Development Agency (RDA) covering the relevant territory.

Note: Local self-governments that already have developed strategies containing the minimum required elements in accordance with Article 29 of the EU Common Provisions Regulation (EU) 2021/1060 are not eligible to apply.

EU Support to Integrated Territorial Development – EU INTEGRA is an initiative financed by the European Union (EU) with 15 million Euros, implemented under the leadership of the Ministry of European Integration (MEI).

Building on the EU PRO Plus Programme (2021–2025), which introduced the Integrated Sustainable Territorial Development (ISTD) model in Serbia, EU INTEGRA advances this approach by supporting 144 local self-governments (LSGs) and Regional Development Agencies (RDAs) across Šumadija and Western Serbia, Southern and Eastern Serbia, and Vojvodina. It promotes evidence-based, EU-aligned governance at national, regional, and local levels to enable balanced socio-economic development.

The Programme is implemented through two complementary components led by the Standing Conference of Towns and Municipalities (SCTM) and the United Nations Office for Project Services (UNOPS).

- Support Chapter 22 alignment through training, tools, and a national ISTD platform
- Build capacity for programming and implementation of Cohesion Policy tools
- Facilitate peer exchange with EU Member States
- Assist SCTM delivery of the integrated projects grant scheme

Regional and Local-Level

- Support the development and rollout of territorial strategies
- Ensure project maturity, encourage innovation, and strengthen access to funding
- Establish and operationalise Project Coordination Units (PCUs)
- Provide technical assistance for planning, coordination, and implementation capacity
- Support accreditation and certification for local stakeholders
